### **RESOLUTION**

**RESOLVED:** That the Council acting as a Screening Committee, shall consider all proposals for membership and cause them to be presented to the Assembly or be filed with the Secretary, but a majority vote of the Assembly can bring a proposal up for ballot if the candidate qualifies under Section 108, Paragraph A.

1. Any member in good standing may recommend an eligible York Rite Mason for membership.
2. A unanimous vote of those members present at a Regular Assembly, or a Special Assembly called for that purpose, shall be necessary for election for membership.
3. Upon the election of the one proposed, previous to his receiving the Order Knight of York there shall be delivered to the Secretary an Acceptance of Invitation, signed by the proposer and other sponsors and accompanied by the proper fee.
